For Articles:

Also, your experience as an author may be of interest to readers, many of whom are also writers. Articles range between 800-2000 words.

For Short Stories:

We are interested in short works of genre fiction, in particular suspense, crime/detective, military and paranormal, within a range of 1500-2500 words.

For publication consideration, please email a request for your Submission with the following information: (1) a brief description of the content you wish to publish; (2) your literary background, your resume or a link to your online biography; and (3) your contact information. For purposes of these Terms and Conditions, the word "Submissions" shall mean any text, messages, ideas, concepts,

pitches, suggestions, stories, artwork, photographs, drawings, audiovisual works, your and/or other persons' names, likenesses, usernames, profiles, and/or other biographical information or content, that you submit, post, upload or display on or through the Website or its associated email addresses, blogs or other information systems or portals.

\$200 for short stories (fiction only)
\$80 for articles of 1000 words or more
\$50 for articles with less than 1000 words.

We do not accept works that have already been published. In rare cases, we may offer higher payments and alternate licensing arrangements, subject to a written agreement.
